LATC Registrar regularly reviews credit for prior learning policies. This table is subject to change without notice.

Student must provide sufficient evidence to the registrar and the applicable department that prior learning has taken place.

- Health certifications or documentation of prior work experience are the most commonly submitted types of evidence for prior learning.
- The department will determine the appropriate format to submit evidence of prior learning. Example formats for evidence are a letter from a previous employer or an online registry with which a department can verify a certification.
- Health career-specific prior learning should be considered in conjunction with other types of prior learning, such as CLEP or DSST testing.
- Contact the Registrar (if enrolled, contact your department chair), to address program-specific prior learning.
